Dear Ladies and Sirs,

There is no choice between having tight trade relations with the EU or with the Russian-led Customs Union. Technically Ukraine can secure free trade with both trading blocs, i.e. with the EU and the Customs Union. This can be achieved in the short term, by having parallel free trade agreements with both economic spheres.

Since Ukraine already has a free trade agreement in the framework of the CIS, the goal of free trade with both trading blocs can be achieved just by signing a free trade agreement with the EU (“DCFTA”).

A decision for Ukraine between “**East and West**” is thus technically not necessary, as often stated by politicians from both sides. Yet, the major question is, whether the countries of the Customs Union and in particular Russia will discontinue the existing CIS free trade agreement with Ukraine, for which there are no technical reasons.

During this event experts from Germany and Ukraine will discuss their point of view on such parallel FTAs and what ways exist to achieve this goal.

This is an event jointly organized with the Chamber of Commerce and Industry in Ukraine and other business associations.
